
#### History of the Christmas tree lights

In 1882, in a townhouse at 136 East 36th Street in New York City, Edward Hibberd Johnson had an idea that would make him the unsung set decorator of a zillion holiday snapshots. Johnson, Thomas Edison and others invested \$35,000 to form the Edison Lamp Company to sell the recently invented light bulbs.

Before long, Johnson had a bright idea. At that time, what really made a tree a Christmas tree were the candles, and while flickering flames were festive, they were also a fire hazard.

Over at the Edison shop, Johnson saw an opportunity. Setting up a tree by the street-side window of his parlor, Johnson hand-wired 80 red, white and blue light bulbs and strung them together around it, and placed the trunk on a revolving pedestal, all powered by a generator. The lights drew a crowd as passers-by stopped to peer at the glowing marvel.

Johnson's lights were indeed ahead of their time—electricity was not yet routinely available—and they weren't cheap. A string of 16 vaguely flameshaped bulbs sitting in brass sockets the size of shot glasses sold for a pricey \$12 (about \$350 in today's money) in 1900. But in 1894 President Cleveland put electric lights on the White House tree, and by 1914, a 16-foot string cost just \$1.75. Today an estimated 150 million light sets are sold in America each year, it all started with Johnson's miracle on 36th Street.

Everett Dale Johnson, age 80, of Friendship, while in route to Florida for the American Legion Run 2019, to raise money for disabled service members children, became a victim of an accident which caused his death on August 21, 2019. Everett was born March 10, 1939 in Hill Township, Price County, Wisconsin to Martin and Phoebe (Cutts) Johnson. He graduated from Prentice High School in 1959. Everett was in the Army, stationed in Korea as a combat engineer from 1962-1964. Everett married Florence Schneider in Colby, Wisconsin on July 23, 1966.

Everett worked on road construction in Milwaukee and Menomonee Falls before moving to Friendship, where he worked at Castle Rock driving truck and at the plant, Adams; Fischer Trucking, Fenwood, WI; Daily Express, Carlisle, PA; Jevic, New Jersey; Construck, Plover, WI; Brock Trucking, Vesper, WI; Retzloff, Berlin, WI; and Alsum Transport, Friesland, WI. He boasted of driving for sixty years – one kind of a truck or another, trailer, flatbed or drop deck. North, south, east, or west – where ever it took him, he was sightseeing.

Everett was a life member of the VFW Oxford Post 6003, life member of the Old Farmers Antique Club, life member of the American Legion Rider District #11, life member of the Knights of Columbus #6718, member of the American Legion Post 452 (47 years), and a guest member at American Legion Riders District 8 from Wisconsin Rapids. He enjoyed hunting, snowmobiling, bowling with the K.C.'s, riding his trike, working at the VFW Oxford 6003 for fund raisers, funerals, bingo – or whatever he could help with. American Legion Riders District 8, Wisconsin Rapids was so much closer than his District 11 – Everett helped District 8 to bring in the 14 Honor Flights at Mosinee (after he himself had gone on the Honor Flight). Everett raised money for Wreaths Across America, wreaths to be placed at King, WI.

Everett was preceded in death by his parents, Martin and Phoebe; his Ma, (Ruth) Johnson; brother, Elmer Johnson; sister, Louise Karlic; sister-in-law, Judy Molley; and brothers-in-law, Melvin Schneider and Verland Schneider. He is survived by his wife, Florence Johnson of Friendship; son, Dale Johnson of Friendship; son, Kenneth Johnson of Lake in the Hills, IL; grandson, Alan (Amanda) Johnson of SOMEWHERE; sisters: Mary (Kellen) Arnold and Audrey Allen; brothers: Frank Molley; Don (Janice) Johnson; Roger Abts; Ralph (Janet) Abts; Ronald Abts; and brother-in-law, Jack Karlic. # Relocating Our Yesterday House

and putting into storage our historical artifacts until a new Machine Shed can be built.







Several file cabinets and countless boxes of artifacts, books, magazines and historical information were moved out of the basement and upstairs office.

boxed for storage until we are
able to build a new Machine
Shed at the new site at the
Spirit Town Hall.



All the books in the Liberty School library were boxed and hauled away for storage.






With the help of a tractor and loader, the entrance ramp into the Yesterday House was taken apart, railroad ties were loaded off to the side and all the decorative stone that made up the ramp was loaded up and moved.



Throughout the winter months all the legal technicalities were taken care of.





A rectangle beginning at point of origin (point A) located:

64 feet from center of Four Oaks Road 54.5 feet from NE corner of metal shed 58.25 feet from NW corner of metal shed Then west to point B located:

72.7 feet from NW corner of metal shed 54.8 feet from NE corner of fuel tank cement 58 feet from light pole

82.25 feet from NE corner of town hall building Then north at 90 degrees for 75 feet Then east at 90 degrees for 80 feet Then south at 90 degrees for 75 feet to the point of origin.

Landlord shall grant Tenant access to the site from the parking lot area on the south side of the site.

A location was agreed upon by the Spirit Town Board and Spirit Historical Society. A description and map was filed with the Register of Deeds in Phillips, WI and steel posts were driven to mark out our new location.

A contract was signed with a moving company, permits were acquired to make the move and we awaited the day when the Yesterday House would make its move from German Settlement Road to State Hwy. 86.

Advertising was done to inform the public of our intention to relocate and generous donations started coming in to fund our project. We are still seeking donations (private and business). With a minimum contribution of \$200.00 your name or your business name will be placed on a permanent word plaque honoring the Friends of the Spirit Historical Society who helped make the relocation possible.



Mid July an excavator was hired to prepare the new location.

Top soil was pushed aside and the proper sized hole was

made in the SW corner of our lot.



Meanwhile back at Liberty School the process began to get the log building ready to move out. Our Yesterday House was jacked up and sets of wheels were put underneath the building. Long iron beams were in place in both directions to keep the building level as it was jacked up.



Leaving nothing behind except an empty foundation that had served its purpose since 2003.



A cement footing was poured and loads of rock were brought in to fill inside and out.





Once the building was safely and securely attached to all the wheels, it was pulled off of its location and parked next to German Settlement Road....ready to be hauled away.



Early the morning of July 30<sup>th</sup> the crews showed up to start the big move. Michael and Toni watched as the old log house left their property.











The route taken was west on Cty. YY to State Hwy. 102, then north to State Hwy. 86, then back east to the Spirit Town Hall. The big hills on YY required having a backhoe chained to the building to prevent any issues of going too fast down hill then to help pull up hill again.



The crew from Price Electric came from Phillips and volunteered their time to raise or remove wires to accommodate the almost 24 ft. of height needed to get the building down the road.

Price County Sheriff's Dept. supported us by sending officer Gabe Lind to serve as a free escort on the state highways.

A huge thank you goes out to all of them. They did an excellent job for us at no cost to our organization!





Once the building was beyond the parking lot, the truck was detached and a backhoe was attached by chain to pull the building up to the ramp by the foundation site. From there the truck became the winch that pulled the building down the ramp into position and the backhoe was chained to the back of the building to keep it from rolling down into the hole to quickly.









Cribbing was positioned on all 4 corners and the building was jacked up hydraulically until it was six feet above the footings, allowing for the foundation walls to be poured underneath.





All the wheels were pulled out from under the building. Ready for the next step of pouring cement foundation walls.





In order to make the site safe until walls could be poured, we put up a fence and warning signs to deter anyone from going under the building. Mark Nyberg, Scott, Katelyn & Derek Schult and Darrel & Luann Lind helped get the fence up.





Four foot foundation walls were poured first. Then a few days later a floor was poured inside the walls. A layer of plastic and styrofoam was put down first. This floor will prevent any moisture from coming up from the ground onto the bottom of the building.








One last project evening was spent before the building could be put down on the foundation. Darrel Lind & JaNelle Nelson took down the fencing while Tim Nelson & Luann Lind added 2x8 treated boards to the bottom of the east and west ends of the building to level the bottom of the building all the way around.









On September 20<sup>th</sup> the building was finally lowered into place and all the steel beams and cribbing were removed.







After waiting for a VERY rainy fall to let up and before the frost had the ground frozen too deep, finally on November 7<sup>th</sup> an excavator was able to get in to our site to backfill around the building. A drain was installed from the SE corner of the footings out to the ditch to the east. This will take care of any water that finds its way to the bottom of our foundation walls.



For this year our project is finished.
It will take the winter months to
settle all the backfilled dirt.

Next spring there will be more leveling and landscaping. Topsoil will be spread over all the fresh dirt. We will then move our household display items back into the log home and start building a new ramp to access the front doors.

A plan is in place to plant flowers and seed down the rest of the area.
